INTRODUCTORY WORKSHOP ON TRANSGENDER HEALTH 1st May 2022

Introduction

ATHI (Association for Transgender Health in India) in collaboration with HPQI (Health Professionals for Queer Indians) organized an interactive, Introductory Workshop on Transgender Health for the healthcare professionals (Doctors, Nurses, Paramedics, Medical Students and Nursing Students) at The LaLit New Delhi on the 1st of May 2022 from 08:30 AM to 4:30 PM. The workshop was conducted by domain experts and professionals of national and international repute working in the field of Transgender Health. This was the first in the series of offline workshops to be held by ATHI with the aim of creating a trained human resource by educating the healthcare providers and enhancing their skill sets for the delivery of evidence based, standardized, ethical Transgender Healthcare in accordance with the Indian Standards of care (ISOC 1) and Standards of Care 7 released by the World Professional Association for Transgender Health (WPATH).



















The Guests of honour, Dr Shobini Rajan, MD (Pathology), Chief Medical Officer (Senior Administrative Grade), Targeted Intervention and LWS Division I/C National AIDS Control Organization Ministry of Health and Family Welfare, and Dr Maneesh Singhal, HOD Reconstructive Surgery, who has been designated as Nodal Officer for the upcoming Centre of Excellence in Transgender Health, AIIMS, New Delhi apprised the participants about the path breaking initiatives taken by the Ministry of Health and Family Welfare who under the able leadership of NACO have partnered with the community, to not only create the framework required for the delivery of Transgender Healthcare in the country but also laid the foundation for training of the required human resource for implementation of holistic, affordable, accessible and affirmative care to persons with gender incongruence and people with differences in sexual development/orientation. Dr Shibu John, Professor and Dean, Department of Health and Pharmaceutical Management, Jamia Hamdard University, conveyed the commitment of the university towards increasing awareness and imparting education in this emerging field of Transgender healthcare. He was speaking on behalf of Professor (Dr) Mohammad Afshar Alam, Vice Chancellor, Jamia Hamdard University who along with Ms. Radhika Chakravarthy B, Joint Secretary, Ministry of Social Justice and Empowerment had sent their regrets for not being able to attend the workshop.

Having felicitated the guests of honour in the inaugural session, Dr Sanjay Kalra, President IPATH (Indian Professional Association for Transgender Health), the professional arm of Association for Transgender Health (ATHI), gave an overview of Transgender Health and reiterated that it would be his endeavour to marshal the IPATH members to strengthen the hands of the Ministry. He pledged to assist the Centre of Excellence by actively participating in the ongoing training of healthcare providers and facilitating research activities. He stressed on the need for reinforcing private public partnership.

The tone of the workshop was set by <u>Dr Kavita Arora</u>, <u>Adolescent and Child Psychiatrist</u> and <u>Dr Amrit Pattojoshi</u>, <u>Psychiatrist and EC Coordinator LGBT Task Force of Indian Psychiatric Society</u>, by emphasizing the need for all care providers to be mindful and understand the vital role of Mental Health Provider for delivery of affirmative care and integration of the individual with society enjoying equal rights and privileges as bestowed to all citizens by the constitution.



















The entire workshop was designed on an interactive small group discussion format by dividing the participants along with the experts into four groups taking care that each teams had a more or less equal representation from the community members, medical experts/surgeons, mental health professionals, social workers, paramedical/nursing staff and students/residents. There were a total of 52 participants who attended the workshop along with 19 experts from the various fields of Transgender health. The list of the experts along with their brief profile is annexed.

Five sessions with a lunch break had been planned. The detailed agenda is annexed. Each session flowed into the next, enriched by the learnings gained from the previous one through interactions between the group members, guided by inputs from the experts and directions given by the moderators chosen for the session. Different case scenarios based on a hypothetical individual named "Bacchu" were presented by the moderator to the teams. The team members then discussed the various situations among themselves, identified the medical and social issues faced and devised management strategies. The participants were also encouraged to deliberate on the current practices based on the published standards of care and extracts from the draft SOC 8 which had been sent to each participant prior to the workshop. The pre-lunch session addressed the Mental Health issues and social Issues related to Transgender Healthcare, while the post-lunch session covered Gender Affirmative Care, Dr Satendra Singh educated the gathering about the Medical Ethics and Legal aspects of affirmative care. This was followed by an interactive session in which the participants guided by the experts deliberated on the hurdles to the delivery of Transgender Healthcare and chalked out the way forward. The workshop concluded at 4:30 PM with the collation of the take home messages and a commitment by the participants to undertake the task of putting together a "Textbook of Transgender Health", written with the collective effort of the participants under the mentorship of the experts who had conducted the workshop. It has been proposed that the said "Textbook on Transgender Health" be released during the inaugural session of the third international conference on Transgender Healthcare, IPATHCON 2022, scheduled to be held at Jamia Hamdard University on the 1st and 2nd of November 2022.

Take home points

- 1. Gender dysphoria can be mitigated by early recognition and provisioning of a nurturing environment and affirmative care. Family members, Primary Care Providers and Schoolteachers to be sensitized regarding gender and sexuality and prevent bullying and abuse.
- 2. Pediatrician to take the lead by looking at all children from the developmental perspective and monitoring development of gender and sexuality through childhood into adolescence and beyond. They should help to normalize presence of gender incongruence and differences in sexual orientation by educating parents and family members and providing a tool kit of resources promoting affirmative and participative care.
- 3. Healthcare providers need to advocate for equal rights and life of dignity for the individual. Highlight the need for creating safe spaces and gender friendly infrastructure such as washrooms, formulating gender neutral policy regarding school uniforms, having anti discriminatory policy in educational institutions and workplaces so as to improve mental health of the individual.
- 4. Community support groups and parent support groups can play an important role in ensuring a nurturing environment conducive for attaining good mental health, creating safe spaces and enforcement of redressal mechanisms.
- 5. Need for giving wide publicity through media for increasing awareness among the community members regarding the various initiatives taken and schemes implemented by the Government and registration of the community members on the national portal for transgender persons launched by the Ministry of Social Justice and Empowerment.
- 6. The healthcare provider to take on the role of facilitator and follow the informed consent model for delivery of affirmative care ensuring that medical ethics are followed and all decisions regarding the quantum and type of interventions are made by the individual.
- 7. Early gender affirmative intervention such as the use of puberty blockers to be considered if there is increasing gender dysphoria. Voice therapy and nonpharmacological gender affirmative interventions should be made available for reducing dysphoria.
- 8. All care providers should be well versant with the current standards of care and should provide care and follow-up by multidisciplinary, well trained, and certified Gender Affirmative Care Teams.
- 9. Written protocols and policies to be formulated and certification of healthcare facilities as Gender Friendly to be undertaken on the lines of NABHL.
- 10. Transgender Health should be included as a subject in the medical curriculum and taught at both undergraduate and postgraduate level. The teacher training curriculum to include training psychosexual development, gender, and sexuality.
- 11. There is need for developing a "Community Cadre" of healthcare providers with community representation at all levels of delivery of Transgender Healthcare.











- 12. Though there is exhibition of political will by the government for implement of the Transgender Persons Protection of Rights Act 2019, however there remains an acute shortage of trained human resource and infrastructure for the delivery of affordable, accessible, and standardized care in most states of India. There is a felt need for reinforcement of private public partnership in order to accelerate training of human resource and enhance the quality of Transgender Healthcare delivery.
- 13. The Gender Affirmative Care is only available in large metro cities with poor penetration in the rural areas. Intersectionality further compounds the issue by creating barriers to care on account of religion, caste, region, educational status, socioeconomic status etc.
- 14. The issues related to long term care, aging, companionship, parenting, lifestyle disorders and preventive health need to be addressed alongside prevention and treatment of HIV and other sexually transmitted illnesses.
- 15. Integration of the 'community-based' and 'community driven' healthcare delivery models with the Center of Excellence is the need of the hour.
- 16. Mainstream media should increase visibility of diverse people by putting out their stories and increasing awareness about issues faced by them.



Narrative for the moderation of the session on Gender Affirmative care

Bacchu, a gregarious child, who was ever eager to participate in all class activities, is found to have suddenly become reserved and withdrawn. You had noticed that though Bacchu, since the very beginning, would not engage in rumble-tumble play activities with other children but they would be very happy playing house. Since last few days they refuse to interact with any of their classmates and has become very irritable. They choose to sit alone and brood.

Issues

Psychosexual development Gender identity, fluidity, Sexual orientation

You run into Bacchu's mother at the school gate as you are leaving for home. During casual conversation you come to know that Bacchu's teenaged cousins have come for a holiday to Delhi and are staying at his house. Bacchu does not like them since they tease them for being different. Bacchu's uncle has also commented on their behavior.

Issues

Gender affirmative environment Prevention of abuse and trauma

Bacchu's mother is getting worried since Bacchu who would earlier share the minute-to-minute account of the days activities has started closeting themselves into their room. There have been instances of flying into rage and self-harm.

Issues

Closeting
Minority stress
Mental health – unmasking of psychiatric issues
Neurodiversity

Bacchu has confided in their sibling that they feel very uncomfortable with the changes happening in their body. They have been chatting with other adolescents online who have practicing binding and tucking for passing and have been taking some medicines to prevent changes. She suspects that the child has fallen in bad company and is concerned about their high-risk behaviour.

Passing- binding and tucking, voice modulation
Laser therapy
Puberty Blockers – indications cover the why, when & how











A friend of Bacchu's mother has told her that one of her distant relatives was facing similar issues with her child. She told her that they had been under care of a team of healthcare providers and had consulted a reconstructive surgeon.

Hormonal interventions – Masculinizing and Feminizing hormonal intervention Gender Affirmative Surgical interventions Letters of recommendation

Bacchu's mother is concerned about the side effects of these interventions and wants to know if her child would be able to raise a family.

She also wants to know the long-term consequences and life after 50

Bacchu's mother herself remains distressed due to the issues happening in the family and the reactions of other family members. Its taking a toll on her health. She also wishes to reach out to other parents and children who are facing similar issues.

He is a Board Member of National Council for Transgender persons by the GOI and in September 2021 started trans-led salon to create employment opportunities. He has been helping community in getting enrolment in skill training courses and advocacy and sensitisation program with government bodies and MNC's.

For him, bodybuilding was never just a way to enhance physical self, but to make a powerful statement. And he did so by participating in IBFF India as country's first trans man to compete in bodybuilding championship. Aryan's battles against the society and its stereotypes had begun early in his childhood. It was only at the age of 16, that he came out to his parents, and initiated the transition at 18.

Today, Aryan became a ray of hope and an advocate of sorts for other transmen. Aryan has been an active championeer for social causes and for sporting and healthy lifestyles. He has a considerable following both in the LGBTIQ space and amongst general communities and would be a great asset to messaging on youth and gender equality.

DR HARISH PEMDE



Harish Pemde is the Director Professor of Pediatrics at Kalawati Saran Children's Hospital and Lady Hardinge Medical College, New Delhi and affiliated with the University of Delhi, India. He leads the Centre for Adolescent Health, which is a WHO Collaborating Centre for Training and Research in Adolescent Health. He is involved in clinical patient care as well as research activities and serves as a member of the Technical Advisory Group in Adolescent Health in the Ministry of Health and Family Welfare, for the government of India.

Current research interests include validation of a screening tool to identify adolescents requiring detailed medical evaluation, quality improvement strategies in child and adolescent health practices, and development of mobile applications for doctors, parents, and adolescents.















Dr Alpesh is an Assistant Professor, Endocrinology at AIIMS, New Delhi and is MD (Medicine), DM (Endocrinology) and has published 70 indexed national and international journals and also 10 book chapters.
